



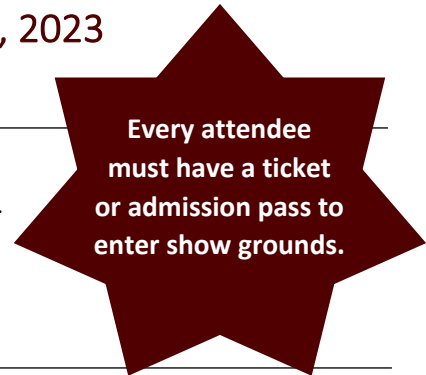

- Early arrival: may arrive on Thursday 3/9/23 to set up and/or camp on site, no additional charge.
- Early departure: please no early departure, we will allow removal of equipment and/or RVs on Sunday 3/12/22 after 3pm.
- Security will be on site starting Thursday 3/9/23 through Sunday evening 3/12/22.
- All exterior gates will be shut and locked between the hours of 9pm & 8am.
- Security will be available to let attendees out after hours for emergencies. Security contact information will be supplied in you packet.

TERMS – EXHIBITOR SHALL:

- Agree to all safety rules, exhibit an appropriate display; agree to hold harmless & indemnify Cal Shows, Central Valley Sportsmen Boat & RV Show and Kern County Fairgrounds, staff & volunteers for any losses, damages or injuries incurred during the show.
- Keep volumes of sound at reasonable levels (no obscene/lewd lyrics).
- Not damage or deface the property.
- Observe all state & federal safety regulations, operate vehicles in a safe manner, drive 5 MPH on the grounds at all times and grant driving permission only to those with an up-to-date, state issued driver's license.
- Not solicit money or signatures without permission from management, including the sale of raffle tickets for other shows, events or locations.
- Not sublet any space, pay for what you use.
- Not infringe on any vendor's space.
- Keep outside food & beverage in RV area.
